Grounds Maintenance It was noted that the last grounds maintenance invoice has been paid which included additional work on trees to the rear of the cemetery to be completed by the end of November to allow letting of allotment plot. AB to follow up.

Closed Churchyard Discussion took place regarding the wildflower area. MM and AB will meet as an informal working party to plan the way forward for 2022 and would very much like Phil Anderson to join the group. Noted - Churchyard Quinquennial report is now complete and will be made available in January.

Cemetery Memorial request for the late Betty Paterson approved. The New Cemetery plan and register has been checked by MM and AN concluding there are possibly 11 vacant plots. This will need confirming by rodding with a cost of approximately £280 . Rodding was proposed by MM and seconded by MD **Resolved** - rodding to be commissioned.

Allotments Discussion took place concluding that the available plots should be offered to those at the top of the waiting list.

Play Area - Cllr Crossman reported that the replacement posts have been installed. The Bee Maze has been delivered. D Crossman is to arrange installation

Cricket Pitch – no update.

Public footpaths – Walking and checking of path number 6 will take place in January by Andrew, Barbara and Steve. Many thanks to Barbara Cattermole who had arranged work on the broken bridge on NB Footpath 5.
